called in due time. The Secretary BoG, Mr. Tahir Maqsood (D.G. PITAD) presented agenda item one by one for consideration of the Board, with the permission of the Chair. Minutes of the last meeting were confirmed. The decisions of the Board are given below:-

Agenda Item No.1

Action taken on decisions of BoG in last meeting held on 24 January 2009.

The Secretary BoG Mr. Tahir Maqsood appraised the Board with the actions taken on the decision of the last BoG meeting held on 24 -01- 2009. The Board expressed satisfaction over the action taken on the decision of the last meeting.

Agenda Item No.2

Approval of Specialized Training Program and other Training Programs by the BoG.

Secretary BoG presented the agenda item. Secretary Ministry of Foreign Affairs inquired about the syllabus and the other activities undertaken during the STP. Director General PITAD briefed the Board about the STP activities. He further informed that PITAD is offering a short training course for the officers of Foreign Service of Pakistan. Secretary Commerce highlighted the importance of the syllabus and activities undertaken during the STP.

Regarding training of trade officers (Designate) abroad, Secretary Ministry of Foreign Affairs proposed that trade officers of other countries posted in Pakistan may be invited to have an interaction/share experiences with the respective trade officers. Secretary Commerce/Vice Chairman BoG appreciated the proposal and stated that he would explore this opportunity. On a query raised by Chairman NTC, Prince Abbas Khan about the short duration of the course for trade officers, Secretary Commerce/Vice Chairman BoG explained that a comprehensive training programme was conducted. Moreover, the trade officers (Designate) were also exposed to Chambers and associations etc. **The Board of Governors approved PITAD's training programme as under:-**
